What is I2I?

Invest 2 Invest was created by Jack Stack, founder and CEO of SRC Holdings Corporation, to generate a new source of revenue for Boys & Girls Clubs of Springfield. The program teaches business basics to Club members, and provides friendly competition for savvy investors!



How does I2I work?

Each player selects a publicly traded stock they believe will rise in value by the end of the year. The number of shares purchased should total approximately \$1,000 at the start of the competition.

Your stock's performance will be tracked monthly, and players will receive email updates throughout the year with leaderboards and highlights!

The player whose stock increases the most in value by year-end will be crowned the winner — but even if the market dips, our kids still win! Each participant's \$1,000 investment becomes a gift to support the life-changing programs at Boys & Girls Clubs of Springfield.

What are the benefits to me?

The game wraps up with a special celebration for all participants, where we'll recognize winners, enjoy refreshments, and celebrate the impact your investments made possible. Your gift is fully tax-deductible — and every dollar helps local youth create brighter futures.

What else should I know?

At the end of the competition, players transfer their shares of stock or donate their full market value to Boys & Girls Clubs of Springfield. **If a stock decreases in value, the player still pledges to donate a minimum of \$1,000 to BGCS.**
